PROMOTE THE PREVENTION OF CONTAMINATION AND ENVIRONMENTAL PROTECTION

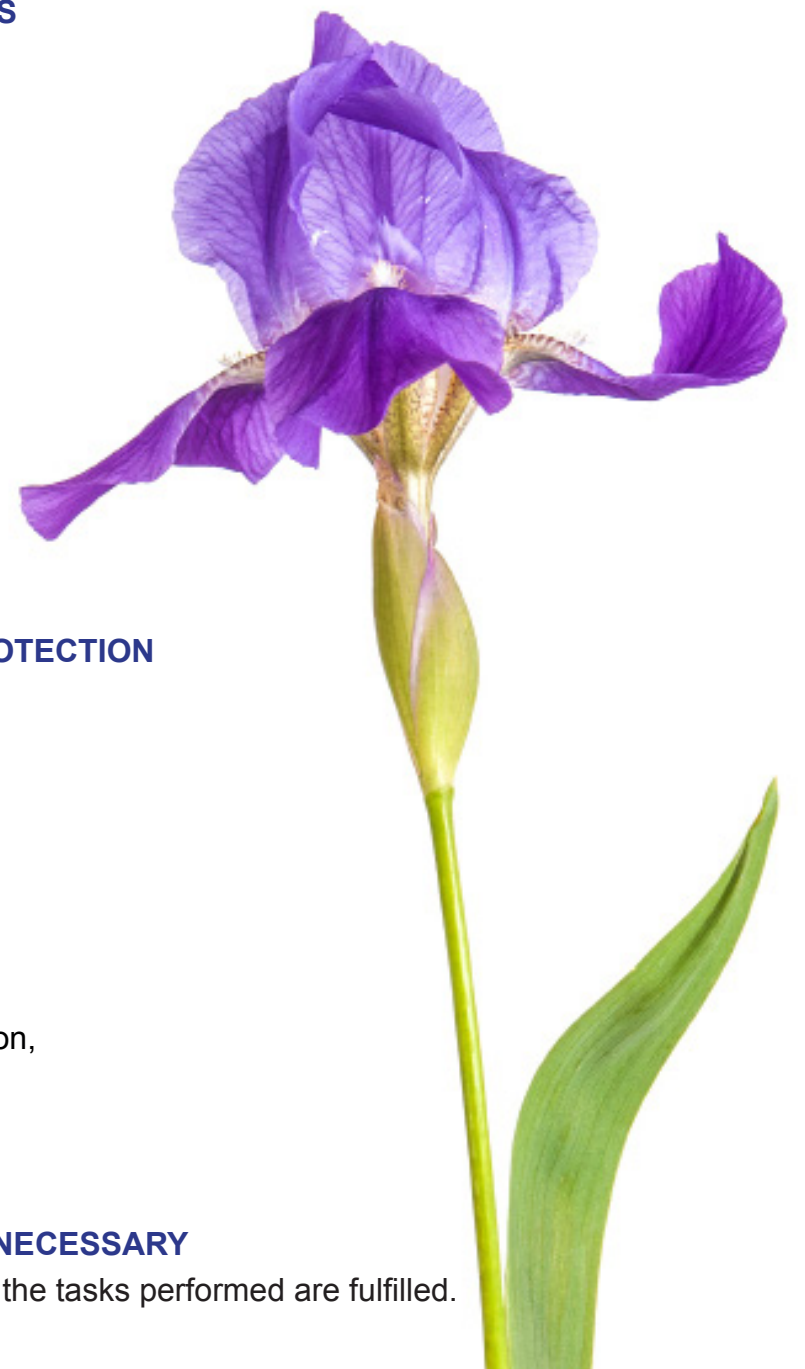
